JA Canada has been providing financial literacy, workplace readiness and entrepreneurship programs in partnership with the Canadian education system since 1955. Designed to inspire, prepare and help youth succeed, JA provides more than 450,000 learning experiences to youth across Canada annually. JA in Ottawa reaches more than 7,000 youth in grades 3-12 in the Ottawa region, with a goal to increase reach in new communities.

JA in Ottawa is hiring a **Company Program Coordinator** who will report to the VP, Programs for JA Canada and work closely with the Program Manager, Ottawa. You will work collaboratively with the team and will coordinate all Company Programs and assist with events that will enable JA to fully support the teacher and student experience. While some of your work can be done virtually, travel within the Ottawa region will be required as needed. ## **Key Responsibilities**

- Promote the Company Program and its benefits to teachers, potential volunteers, students, and schools.
- Manage registration and communications with program facilitators and participants.
- Liaise with teachers to provide support and training as required for Company Program facilitation.
- Recruit and manage volunteers to facilitate Company Program including screening, training and stewardship.
- Provide access to Company Program resources for teachers, volunteers and students.
- Support Company Program events for students and teachers including trade shows and awards ceremonies.
- Serve as the key contact for any Company Program related inquiries in Ottawa.
- Track progress and engagement of teachers and students.
- Assess learning goals and outcomes through surveys, interviews, and conversations.
- Participate as part of the JA Canada network in sharing best practices with staff and relevant teams across Canada.
